SUBJECT: Rules Clarifications

Following is a rule clarification issued by the Solo Events Board as a result of a member request.

Sports Racers and Formula cars competing in Modified category are not required to carry on-board fire systems as required by the GCR. Rule 14. Modified Category states: "The Solo II rules shall take preference over the GCR concerning safety requirements for vehicles in this category." Neither Solo II Rule 3.3 Vehicle Safety (nor any other Solo II rule) contains a requirement for on-board fire systems.
